WITHDRAWAL FEES

The Tour operates a policy of paying all winnings direct to a players bank account within 48 hours of the conclusion of a tournament. On most occasions this is actually on the next working day. As a result any player withdrawing from an event without 24 hours notice or, at the discretion of the Tournament Director a very good reason, will be subject to a £30.00 fine. This is to protect the prize fund for all other players. These fines will be retained to enhance the Order of Merit Awards. All fines will be required to be paid before a player next participates in another event.
